

Proceedings of the Joint Director, Directorate of Private Schools, Chennai – 6 K. Dis No. 7352/B4/2023 dated £2 .06.2023

Sub : School Education – Private Schools –Grant of Renewal of Recognition under rule 9 of the Tamil Nadu Private Schools (Regulation) Rules, 2023 – Regarding.

 - 3. Letter Rc. No. 0635/A1/2023 Dated 19.06.2023 of the District Educational Officer, Erode District.

The application received from the Correspondent of The Nest School Matriculation Higher Secondary School, Sathyamangalam, Erode District for the grant of Renewal of Recognition for Standards from LKG to XII for the period from 01.06.2022 to 31.05.2024 has been considered along with the documents and site visit report. The competent authority having been satisfied that the educational agency has fulfilled the conditions prescribed for the grant of Renewal of Recognition , hereby grants the Renewal of Recognition to the above said school for Standards from LKG to XII for the period from 01.06.2022 to 31.05.2024 as per the provisions of rule 9 of the Tamil Nadu Private Schools (Regulation) Rules, 2023.

2. The above permission is subject to the following conditions:-

- (i) the educational agency shall always keep the Structural Stability Certificate, Building Licence, Sanitary Certificate, No Objection Certificate issued by the Fire and Rescue Services department duly renewed and has validity currently;
- (ii) the educational agency shall abide by the provisions contained in the Tamil Nadu Private Schools (Regulation) Act, 2018 (Tamil Nadu Act 35 of 2019) and the rules framed there under;
- (iii) the educational agency shall abide by all the orders and instructions issued by the authorities concerned from time to time;
- (iv) the educational agency shall abide by the provisions contained in the Tamil Nadu Tamil Learning Act, 2006 (Tamil Nadu Act 13 of 2006) and the rules framed there under;
- (v) the educational agency shall abide by the provisions contained in the Tamil Nadu Schools (Regulation of Collection of Fee) Act,2009 (Tamil Nadu Act 22 of 2009) and the rules framed there under;
- (vi) the educational agency shall abide by the provisions contained in the Right of Children to Free and Compulsory Education Act, 2009 (Central Act 35 of 2009) and the Tamil Nadu Right of Children to Free and Compulsory Education Rules, 2011.

- 3. If it is found at any point of time that the educational agency has violated any of the conditions prescribed for recognition or any of the provisions of the above said Acts and Rules, the certificate of recognition granted shall be liable to be withdrawn permanently.
- 4. The competent authority also affiliates the above said school to the State Common Board of School Education
